Whereas, the rental cost and other fees, if applicable, for the date(s) and time(s) set out above is, and other fees (if applicable) required have been added to this rental amount.

Whereas, the reservation incurs a 50% deposit for booking of event. Rentals are on a first come first serve basis. Reservations cannot be guaranteed without a deposit. No reservation is guaranteed or confirmed unless/until this Rental Agreement is signed and returned with the reservation deposit.

Whereas, the City of Kingfisher/Kingfisher Recreation Authority is not responsible for accidents or injury to renter(s), guests, visitors, or any other persons or for the loss of money or valuables of any kind. Renter(s) do hereby agree to release, acquit, and forever discharge the City of Kingfisher/Kingfisher Recreation Authority, its officers, affiliates, agents, servants, employees, its personal representatives, successors and assigns, and any and all other persons, firms or corporations in privity with it, of and from any and all claims, demands, and causes of action, that renter(s) may have, have had, or ever have arising out of or by reason of the renter(s)’ rental for the event.

Whereas, renter(s) agree to indemnify, protect, and hold harmless the City of Kingfisher/Kingfisher Recreation Authority, its officers, affiliates, agents, servants, employees, its personal representatives, successors and assigns, against any claim for injuries, damages, or other consequences asserted by
